The cultural vehicle for this sentiment emerged decades later. Albarn's project—a collaboration with British musician Damon Albarn, Nigerian producer Rollo Armstrong, and Senegalese artist Youssou N'Dour—transformed Ferren's poetic lament into a multimedia experience. The album, *\*The Orange Factory\**, released in 2019, was not just music but a multi-platform narrative: spoken-word poetry layered over experimental soundscapes, archival broadcasts, and interviews. The centerpiece, a reimagining of Ferren's original text, fused analog voice with digital production, symbolizing the collision of memory and modernity. sharp critique. He saw in the poem a resilience that could be amplified through sound, image, and narrative layers. The project began with a core team: Rollo Armstrong, a British producer steeped in electronic experiment
