"Every atom has a story," he writes, "stories of mercury poisoning in artisanal gold mines, of cyanide spills in Ghana, of toxic slag piles in India's industrial belt." He details how multinational corporations often operate in regulatory gray zones, leveraging jurisdictional arbitrage to minimize environmental liability while maximizing profit. Yet, Tuli also highlights grassroots resistance and community-led science. In Nigeria's Niger Delta, local NGOs use low-cost sensor networks to monitor chromium and lead contamination from petrochemical plants, empowering residents with data to challenge corporate claims. In Chile's Atacama Desert, indigenous groups collaborate with geochemists to map lithium brine depletion, demanding that resource sovereignty includes environmental justice. Tuli frames these conflicts not as isolated incidents, but as symptoms of a deeper crisis: the disconnection between inorganic

chemistry's abstract innovation and its material consequences on vulnerable communities. He calls for a "chemistry of accountability," where transparency, participatory science, and enforceable environmental standards are embedded in every stage of inorganic material lifecycles.

China's model is distinct: a state-led industrial strategy that integrates inorganic chemistry deeply into national development. From lithium processing to rare earth magnets, Beijing's control over the value chain enables rapid scaling but raises global security concerns. Tuli contrasts this with India's ambitious but underfunded "Atmanirbhar Bharat" initiative, which seeks to build domestic capabilities in critical inorganic materials—but faces bureaucratic inertia and infrastructure gaps. In Africa, countries like the DRC and Zambia are rich in cobalt, copper, and manganese, yet remain suppliers of raw materials rather than beneficiaries of value-added industries. Tuli argues that without technology transfer and investment in local refining, the continent risks perpetuating a resource curse, even as global demand surges. Brazil and Australia occupy intermediate positions, leveraging mineral wealth while grappling with environmental regulations and indigenous land rights. Tuli's fieldwork in the Pilbara reveals a tension between mining expansion and ecological preservation—where the economics of nickel for EVs collide with the protection of fragile desert ecosystems. He champions “inclusive chemistry”—a paradigm where technical excellence is paired with social accountability. He also foresees regulatory evolution. As digital twins of chemical plants become standard, real-time monitoring and predictive analytics will enhance safety and compliance. Blockchain could trace raw materials from mine to product, ensuring transparency and ethical sourcing.
