In education, 1:30 is disrupting traditional models. In India, where only 3% of deaf children are enrolled in sign language programs, NGOs like Sampada have launched mobile labs—portable kits with tablets, interactive sign dictionaries, and virtual classrooms—to teach 1:30 in rural schools.
