Survival demands resilience, but also alliances—with academics, technologists, and grassroots movements.’ Forwards, the implications are profound. As AI-driven content floods the digital sphere, Allen and Winters’ work points toward a future where human judgment, contextual nuance, and ethical rigor become the decisive differentiators. Their insistence on narrative depth—where data serves story, not the reverse—offers a counterweight to the algorithmic flattening of discourse. Moreover, their focus on Global South perspectives challenges the persistent North Atlantic center of knowledge production, advocating for pluralistic, polycentric truth-making. Economically, their investigations have catalyzed tangible shifts. Regulatory reforms in the EU’s Markets in Crypto-Assets framework cite *Nexus* reports; anti-corruption task forces in Ghana and Philippines have integrated their findings
