The *Mahābhārata*, traditionally dated to 400 BCE–400 CE, is not merely a war narrative but a philosophical treatise. Embedded within the *Bhīṣma Parva* lies the *Bhagavad Gītā*, a dialogue between Arjuna and Krishna that crystallizes *karma yoga*, *bhakti*, and *jñāna yoga*—paths to liberation. Its geopolitical significance is profound: composed amid the fragmentation of the Mauryan Empire and the rise of regional kingdoms, the *Mahābhārata* functioned as a cultural unifier, articulating dharma amid political chaos. Parallel to the epics, the *Dharmaśāstras*—legal and ethical compendia—emerged, most notably the *Manusmṛti* (Laws of Manu), compiled between 200 BCE and 200 CE. Though often misrepresented as immutable law, these texts reflect their historical moment: a Brahminical response to social complexity, codifying caste duties (*varṇashrama dharma*) and gender roles. British administrators, influenced by Orientalist paradigms, often reduced Hinduism to “idolatry” and “superstition,” dismissing its philosophical depth. Yet this same period saw the emergence of textual revivalism: figures like Swami Vivekananda, Aurobindo Ghosh, and Ramanuja's modern interpreters reclaimed the Vedas and Upanishads as rational, universal philosophies, countering colonial narratives. The **Vedānta Deshika** tradition, for instance, repositioned **Advaita Vedānta** as a metaphysical system compatible with modern science, influencing global philosophy. Meanwhile, the **Bhagavad Gītā** was appropriated—ironically—by both Indian nationalists and British strategists: Aurobindo saw its **karma yoga** as revolutionary; British officials cited its discipline to justify colonial “order.” Economically, the sacred texts have long shaped India's cultural industry. The publishing sector—dominated by publishers like SPC Publications, Aditya Birla Group's religious imprints, and independent houses in Varanasi and Tirupati—generates billions annually. Pilgrimage tourism, anchored in textual sites—Varanasi (linked to **Śvetāśvattha** and **Bhāgavata** traditions), Haridwar (associated with **Ganga** and **Mahābhārata** lore), and the **Kumbh Mela** (rooted in **Skanda Purāṇa**)—draws tens of millions, fueling local economies and global spiritual markets. Digital platforms now monetize ancient texts through apps, AI-driven commentary, and subscription-based philosophical courses—transforming sacred knowledge into global intellectual capital. Yet this commercialization raises critical tensions. The **Bhagavad Gītā**, translated over 90 times into English, is repackaged as self-help wisdom, often divorced from its **dharma**-centric worldview. The **Ramayana**, adapted into Indonesian **wayang kulit**, Bollywood films, and Thai **Lakhon Nai**, becomes both unifying cultural symbol and contested site of nationalist appropriation. Unauthorized digital reproductions and derivative works challenge intellectual property norms, especially when sacred content is treated as public domain by colonial-era legal frameworks.
