Similarly, Singapore’s data-driven, digital-first exams offer a model for technological integration, but lack the deep cultural embeddedness seen in Bengali papers, where local narratives anchor abstract concepts. Notably, diaspora education systems—such as Bengali-language schools in Europe and North America—have adapted madhyamik-style assessments to preserve linguistic heritage amid assimilation pressures. These international adaptations reveal a transnational recognition: Bengali education is not merely local, but a vital node in global Bengali identity networks. The question papers,
