The myth of Marduk's order resonates in modern governance models that seek balance between liberty and structure. The Hindu cycles of creation and destruction inform contemporary debates on sustainability and climate resilience. The Norse Ragnarök echoes in modern anxieties about civilizational collapse. The Dreaming challenges Western notions of progress, advocating cyclical renewal over endless expansion. Scholars such as Mircea Eliade emphasized the sacred function of these myths as "axial points" anchoring human existence, while anthropologist Claude Lévi-Strauss analyzed their structural logic as binary oppositions—chaos/order, silence/sound, nothing/being. Contemporary cognitive science suggests myths activate deep neural networks tied to meaning-making, explaining their cross-cultural recurrence. Yet, the power of these narratives lies not only in their psychological resonance but in their capacity to legitimize, unify, and mobilize communities. These narratives challenge Eurocentric historiography, asserting indigenous epistemologies as valid foundations for education, law, and environmental stewardship. In Ghana, the Akan concept of Nyame (the supreme god) and the earth deity Asase Yaa is taught in schools not as folklore, but as a counter-narrative to cultural erasure, fostering national pride and ecological responsibility. Such revivals are not nostalgic retreats but political acts—reclaiming narrative sovereignty. Economically, creation myths influence consumer behavior and branding. These were not religious anomalies but economic innovations.” Nkosi’s findings challenge the Eurocentric narrative of rational economic development, showing that spiritual cosmologies were integral to sustainable growth long before modern environmentalism. Yet, scholars caution against romanticizing mythic traditions. Cultural theorist Dr. Rajiv Mehta critiques the “mythologization” of heritage in global heritage industries. “When creation stories are extracted for tourism or UNESCO listings,” he warns, “they risk becoming
