In Latin America, during

military dictatorships, playwrights like Augusto Roa Bastos in Paraguay used micro-monologues in works such as *\*Yo, el Supremo\** (though longer, its cadence influenced the 1-minute form), embedding personal suffering into national narratives of repression. The brevity allowed dissemination through samizdat, radio broadcasts, and underground performances—efficient, portable, and unignorable. Economically, the form adapted to shifting media ecologies. Television interviews, documentary footage, and early digital storytelling platforms embraced it. Cognitive studies show that responses peak at 60 seconds—long enough to establish character, conflict, and resolution, yet short enough to trigger mirror neuron activation without fatigue. The pacing, tone shifts, and strategic silences align

with primal storytelling rhythms, making the moment memorable. In a world saturated with information, this form cuts through noise by leveraging cognitive efficiency and affective resonance. In South Africa, post-apartheid plays like *\*Woza Albert!\** used short, incisive monologues to challenge institutional amnesia, yet retained communal storytelling elements absent in the isolating 60-second format. The global spread of the form reflects not just influence, but adaptation—how a narrative tool is reshaped by local epistemologies of memory and resistance. If the form remains anchored in genuine testimony, supported by verified provenance, it can sustain its role as a catalyst for empathy and accountability. But without safeguards, it risks becoming another vector of disinformation—another 60-second lie passed as truth. The industry’s response must include ethical frameworks, transparency protocols, and digital literacy initiatives to preserve the monologue’s power without compromising integrity.
