The origins of modern globalization are not new—trade routes like the Silk Road and colonial maritime networks laid early foundations—but the post-1945 institutional architecture redefined its scale. The Bretton Woods system, established in 1944, created a rules-based global economy anchored by the IMF, World Bank, and GATT (later WTO), designed explicitly to stabilize and expand capitalist integration. This was not merely an economic project; it was a civilizational framework, exporting Western liberal democratic norms alongside market mechanisms. As historian David Held noted, this institutional order projected a “diffused hegemony,” where American and European models of governance, consumption, and communication became globally normalized through policy conditionalities, foreign direct investment, and soft power instruments like Hollywood, advertising, and educational exchange programs. Yet globalization’s cultural dimension emerged unevenly. The 1980s, marked by Reagan and Thatcher’s ascendancy, accelerated liberalization. Neoliberal orthodoxy, championed by figures like Milton Friedman and institutionalized through structural adjustment programs, stripped state buffers, privatized public goods, and prioritized market efficiency over social cohesion. Cultural industries—once constrained by

national borders—flourished under deregulated media flows. Transnational corporations like Disney, Sony, and later Netflix began shaping global tastes, not through coercion, but through curated universality: stories that emphasized individualism, romantic love, consumer choice, and upward mobility. These narratives, though ostensibly neutral, carried subtle ideological weight, redefining aspiration and identity around commodified values. Tomlinson emphasizes that this economic restructuring was not culturally neutral. The liberalization of capital and information flows enabled a “global cultural convergence” in consumer behavior—global brands, fashion trends, and digital platforms standardized lifestyles, particularly among urban elites. Yet this convergence coexisted with profound resistance. From the 1990s onward, indigenist movements in Latin America, South Asia, and Africa rejected homogenization, reviving local languages, rituals, and artisanal economies as acts of reclamation. Japan’s “Cool Japan” strategy, for instance, strategically exported anime and cuisine not as passive culture but as state-crafted soft power, blending tradition with innovation to assert cultural sovereignty in a globalized field. Similarly, India’s IT boom fostered a hybrid corporate culture—English-speaking, globally integrated, yet rooted in familial and regional identities—demonstrating how globalization can be

domestically mediated. The digital revolution deepened these contradictions. The internet, initially hailed as a democratizing force, became a double-edged sword. On one hand, social media platforms enabled diasporic communities—from Kurds in Europe to Oromo activists in the Horn—to sustain transnational identities, share narratives, and challenge dominant discourses. Hashtags like #BlackLivesMatter or #MeToo transcended borders, creating global solidarity networks. On the other, algorithmic curation fostered echo chambers, amplifying cultural essentialism and polarization. The rise of “digital tribalism” intensified identity politics, where cultural markers—religion, ethnicity, language—became primary axes of mobilization, often exploited by populist leaders and disinformation networks. Geopolitical shifts further complicated the terrain. The 2008 financial crisis exposed the fragility of hyper-connected markets, triggering nationalist backlashes—from Brexit to Trump’s “America First.” China’s Belt and Road Initiative redefined globalization through state-led infrastructure, embedding Chinese economic influence in over 140 countries, often accompanied by cultural outreach via Confucius Institutes and media expansion. Russia leveraged digital platforms to project soft power through narratives of traditionalism and anti-Western resistance. These rival frameworks—market liberalism

versus state capitalism, universalism versus communitarianism—fueled a new cultural Cold War, where identity became a strategic asset. Industry impacts reveal deeper fault lines. Global media conglomerates, now concentrated in a handful of Silicon Valley and Hollywood giants, control vast shares of cultural production. Their algorithms prioritize engagement, often privileging emotionally charged, identity-laden content that drives polarization.
