In countries like Iran, state-supported fertility clinics provide subsidized contraception and IVF, linking reproductive autonomy to national demographic policy. In contrast, in parts of sub-Saharan Africa, restrictive abortion laws and limited access to contraception force women into clandestine regimes of self-regulation—anatomical life lived under constant risk. Artists working at the intersection of anatomy and identity often draw from these global fault lines. Consider the work of South African artist Zanele Muholi, whose photographic series **Somnyama Ngonyama** confronts the erasure of Black queer womanhood through bold, ritualistic self-portraiture. Muholi's use of makeup, light, and gesture transforms the body into a canvas of resistance, reclaiming anatomical visibility in a world that has historically rendered Black women's forms either hypersexualized or invisible. testament to survival.

Expert Perspectives: Voices Across Disciplines
