The 2021 Chamoli disaster in India, where a landslide destabilized a glacial lake, killing over 200, exemplifies cascading hazards in a warming world. These events strain infrastructure, displace communities, and expose gaps in early warning systems, especially in regions with limited monitoring capacity. Expert analysis underscores the urgency. Dr. Luke Copland, glaciologist at the University of Ottawa, notes: 'Glaciers are memory machines, but their memory is being overwritten—faster than new ice can form.' Dr. Maria Husar of the Polish Academy of Sciences warns of 'tipping points' in ice sheet dynamics, where feedbacks like albedo loss (darker surfaces absorb more heat) amplify melt. Yet adaptive strategies are emerging: in Bhutan, glacial lake monitoring combines satellite data with community-based early warnings; in Canada, ice-strengthening techniques protect alpine trails; and in the Alps, engineered snow storage extends meltwater availability through summer. Long-term implications hinge on two trajectories: one of adaptation, the other of escalating crisis. If global emissions peak before 2030, glacier retreat could stabilize, allowing societies to reallocate resources toward resilience. But at current trajectories, most small glaciers may vanish by 2100, and large ice fields—Greenland, West Antarctica—will contribute meters of sea-level rise over centuries. In these regions, winter snow, with its low density and airy structure, accumulates year after year. Over time, the weight of successive snow layers compresses the lower strata, initiating a phase transition from snowflakes to firn—a granular, porous ice with porosity between 30% and 85%. This firn, through continued loading, undergoes recrystallization: ice crystals grow and merge, expelling air and increasing density to roughly 500 kg/m^3 , marking the threshold of glacial ice. The transformation is governed by the physics of sintering and plastic deformation. At pressures exceeding 50 atmospheres, typical at depths of 50–100 meters, ice crystals deform plastically under stress, a process described by Glen's flow law: the strain rate proportional to stress to the power of 3 (or higher under extreme conditions). This nonlinear rheology dictates how ice flows, enabling glaciers to move even without melting at their base. The transition from snow to ice is not uniform; it depends on temperature, accumulation rate, and impurity content. In polar regions like Antarctica, where temperatures rarely exceed -50°C , firn transforms slowly—over centuries. In temperate glaciers, such as those in the European Alps, melt and refreeze cycles accelerate this process, creating denser, clearer ice with fewer air bubbles. Glaciers form through a feedback loop: sustained cold temperatures preserve snow, which compacts into ice, which then flows under its own weight, carving the landscape and exposing new surfaces to accumulation. This self-reinforcing cycle is sensitive to climatic shifts. A single warm season can reduce net accumulation, initiating a retreat. Yet, in stable cold climates, this balance persists, allowing glaciers to advance over geologic time. The Pleistocene ice ages, spanning 2.6 million to 11,700 years ago, saw vast ice sheets span North America and Eurasia, their growth and

collapse dictated by orbital forcing (Milankovitch cycles) and atmospheric CO₂ variations. Since the Holocene Climatic Optimum (~9,000 years ago), when global temperatures were 0.5–1 °C warmer than today, glaciers have generally retreated, only to advance again during cooler periods—until the current anthropogenic warming disrupted this equilibrium. Today's glaciers are anomalous in both scale and speed. The Last Glacial Maximum (LGM) saw ice sheets covering ~30% of Earth's land surface; today, they occupy just 1–2%, with total ice volume less than half of that from 20,000 years ago. This rapid reduction—over 90% in some regions—reflects not just warming but changes in albedo, atmospheric circulation, and ocean heat transport. The Greenland Ice Sheet, for instance, has lost ~4,700 gigatons of ice since 2002, contributing 0.7 cm per year to sea-level rise. The dynamics of this retreat are governed by both surface melt and basal processes: increased meltwater percolates through crevasses, reaching the bed and lubricating sliding, while oceanic heat erodes marine-terminating glaciers, accelerating calving. Glacier morphology—shape and structure—reflects these dynamic histories. Alpine glaciers, confined by valleys, exhibit high flow velocities and steep equilibrium lines, where accumulation equals melt. In contrast, ice sheets like Antarctica's East Antarctic Ice Sheet flow slowly, driven by internal deformation and basal sliding over bedrock undulations. The presence of moraines, eskers, and drumlins—glacial landforms—reveals past flow patterns and retreat dynamics. Ice cores from these cores now serve as archives: air bubbles capture ancient atmospheres, isotopic ratios track temperature shifts, and particulate layers record volcanic eruptions and dust storms. The EPICA Dome C core, extending 3,270 meters, provides a 800,000-year climate record, showing tight correlation between CO₂ and temperature—yet today's CO₂ levels exceed any recorded in that span by over 40%. The transition from snow to ice is thus a climatic and mechanical process, embedded in Earth's energy balance. As the planet warms, this balance shifts: less snow falls, more melts, and the ice that once stabilized landscapes begins to unravel. Basal sliding dominates in regions where meltwater lubricates the ice-bed interface. When meltwater accumulates at the bed, it reduces effective pressure (the difference between overburden stress and water pressure), lowering shear strength and enabling rapid sliding. This process, known as basal drag reduction, is quantified by the Weertman sliding law, which relates sliding velocity (u) to basal shear stress (τ_0) and water pressure (P): $u \propto (\tau_0 - P) / \mu$ where μ is basal friction coefficient.
