In public policy, cities from Copenhagen to Melbourne have commissioned **The School of Life** to inform mental health strategies, framing well-being not as individual burden but as collective responsibility. These applications reflect a broader paradigm shift: from seeing mental health as a private concern to recognizing it as a public good, shaped by infrastructure, culture, and justice.
