The shift from ephemeral ritual to permanent art was gradual. Frescoes here depict Avalokiteśvara flanked by wrathful deities and celestial dancers, their forms stylized to convey both human empathy and divine power. This period also saw the formalization of ritual calendars tied to the caves. Seasonal ceremonies—such as the Saga Dawa festival—were held in these spaces, drawing pilgrims from across the Tibetan world. The caves became nodes in a spiritual geography, their painted walls serving not just as art but as visual scripture, teaching doctrine and myth to largely illiterate populations.
