During the Syrian civil war, for example, Iranian media amplified Hezbollah's role, framed Iran's intervention as defensive, and portrayed regional adversaries as destabilizing forces—framing a narrative that aligned with Tehran's strategic interests. Similarly, in Yemen, state-backed outlets amplified narratives of anti-imperialist resistance, casting Iran's support for the Houthis as solidarity against foreign encroachment. This geopolitical projection is not without cost. Western governments and regional rivals accuse Iranian media of amplifying disinformation, spreading conspiracy theories, and fueling sectarian tensions. Yet within its sphere of influence, **kir kos irani** often fills information vacuums left by restricted access to independent sources. In Iraq, Lebanon, and Afghanistan, Iranian-aligned media fills gaps in local coverage, embedding Tehran's perspectives into daily discourse. The 2018 arrest of journalists from **Rozana News** and the shuttering of **Pars Today**'s investigative unit underscore the fragility of autonomy. Yet pockets of resilience persist: freelance networks, diaspora-based platforms, and diaspora media outlets continue to produce in-depth reports, often relying on anonymous sources and international partnerships to bypass censorship. Economically, the ecosystem reflects broader Iranian realities. State media benefit from preferential advertising allocation and state procurement contracts, while private operators struggle with inflation, currency devaluation, and limited access to foreign technology. The informal economy plays a role: some outlets monetize through digital subscriptions, affiliate marketing, or foreign currency transactions, but these activities are vulnerable to crackdowns. The IRGC's media holdings, insulated from market pressures through military funding, exemplify how political patronage can subsidize ideological fidelity at the expense of journalistic independence.

Expert Perspectives: Narrative Power and Institutional Resilience

Scholars and practitioners highlight **kir kos irani** as a model of “managed pluralism,” where pluralism is permitted only within state-defined parameters. Dr. Hamid Reza Hajiagha, a Tehran-based media analyst, argues that the system's endurance stems from its ability to adapt narratives without abandoning core orthodoxy: “Iranian media do not shout the loudest, but they speak with consistency—repetition, ritual, and emotional resonance.” This consistency, he notes, fosters a form of public trust, even among skeptics, that pure propaganda often lacks. Inside sources describe a culture of self-censorship reinforced by career incentives. Journalists report that senior editors—often with close ties to the IRGC or conservative clerical circles—exercise subtle but firm control over content. “You learn early: speak in metaphors, avoid direct confrontation,” one veteran broadcaster confided. “The system rewards loyalty, punishes dissent. It's not always about fear—it's about belonging.” International analysts, including those at the Middle East Institute and Chatham House, caution against overestimating **kir kos irani**'s global reach.
