Yet this resistance came with profound risks. In 2020, Detzler’s studio in Berlin was targeted by cyberattacks linked to a state-sponsored actor reportedly monitoring dissident networks. The breach compromised hundreds of unpublished vocal samples from vulnerable sources, prompting a reevaluation of security protocols and ethical data stewardship. No project of such emotional weight is free from peril. The targeting of Detzler's Berlin studio in 2020 exposed the lethal intersection of art and activism. The cyberattack, attributed to a state-sponsored group monitoring dissident networks,

raised urgent questions: How far should an artist go to protect their sources? What safeguards are ethically sufficient when personal trauma becomes data? Detzler’s response was both pragmatic and principled. He dissolved the studio temporarily, relocating to a decentralized network of secure nodes maintained by trusted collaborators.
