The implications are profound: regulators operate in a landscape where compliance is not mandated by law, but negotiated by market actors whose power derives from control of capital, data, and infrastructure. Her testimony underscores the tension between strategic necessity and democratic legitimacy. Legal scholars warn of jurisdictional conflicts. The document's recommendations—such as private enforcement of regulatory standards and cross-border asset freezes—clash with national sovereignty and existing international law. If a private consortium, backed by G20 creditor groups, enforces financial rules without state consent, what legal mechanisms validate its authority? The absence of transparency creates fertile ground for abuse: capital controls, exclusionary market access, and speculative sabotage could all be justified under the guise of systemic stability.
