They parsed millions of documents using natural language processing tools trained on diplomatic lexicons, identifying patterns of coordinated disinformation, shell company flows, and strategic leaks designed to manipulate public perception. Economically, the affair exposed systemic vulnerabilities. The book revealed that between 2018 and 2023, over \$420 billion in undisclosed offshore assets were routed through jurisdictions like the British Virgin Islands, Panama,

and the Cayman Islands—many linked to individuals implicated in the scandal. These flows were not random; they formed networks that exploited regulatory arbitrage, enabling tax evasion, money laundering, and the financing of political manipulation. The investigation showed how multinational corporations, particularly in energy and tech, leveraged these same structures to obscure supply chain risks, externalize liabilities, and insulate leadership from accountability. In doing so, **Unraveling the Affair** laid bare the symbiosis between corporate malfeasance and political corruption—a nexus that has long operated in the shadows but now came under sustained scientific scrutiny. The industry impact was immediate and far-reaching. Traditional media outlets faced existential pressure as audiences demanded not summaries, but deep context.
