Expert Perspectives: Legitimacy, Tension, and Influence

Scholars and practitioners offer nuanced assessments of CRPC’s role. Dr. Anjali Mehta, a governance scholar at the Indian Institute of Management, Bangalore, notes: ‘CRPC’s strength lies in its legitimacy as a non-partisan, evidence-based entity. Unlike advocacy groups, it bridges the gap between theory and practice, offering tools that regulators and firms can adapt without ideological friction.’ Yet she cautions: ‘Its influence depends on sustained engagement. Without deeper institutional embedding—say, mandatory CGI inclusion in stock exchange disclosures—the gains risk

being superficial.’ From the corporate side, Sanjay Patel, former CFO of a Fortune 500 Indian subsidiary, emphasizes: ‘CRPC didn’t dictate reforms—it enabled them. By providing benchmarks and peer comparisons, it created a competitive incentive. Boards now view governance not as a box-ticking exercise but as a strategic asset.’ Conversely, some legal experts caution against over-reliance on private advisory bodies. Professor Ravi Nair of the National Law School, Karnataka, warns: ‘While CRPC’s work is valuable, the absence of statutory enforcement weakens accountability. Governance standards remain voluntary, vulnerable to corporate window-dressing. True reform requires legislative teeth.’ These tensions reflect a broader debate: the balance between voluntary self-regulation and mandatory compliance. Transparency in funding, decision-making, and stakeholder representation remains an ongoing challenge.

governance reforms, driven by judicial activism and shareholder lawsuits, highlight the limits of advisory bodies without strong legal repercussions. CRPC's distinct advantage lies in India's unique context: a federal democracy with vibrant civil society, a burgeoning investor class, and a regulatory landscape in flux. It leverages soft power—through education, data, and dialogue—rather than coercion, fostering organic adoption.

Looking ahead, CRPC faces both opportunities and imperatives. By establishing partnerships with state-level industrial development boards and tribal enterprise networks, it seeks to extend its reach beyond Mumbai’s financial elite. CRPC advocates for mandatory governance disclosures tied to capital market access, a policy shift requiring political will. It also promotes

Experts foresee CRPC evolving into a global knowledge hub, exporting its model to South Asia and Africa. Its experience in balancing regulation and innovation could inform emerging market transitions, where rapid growth demands robust institutional scaffolding.
