Expert perspectives reveal a schism in how pedigree pogil is perceived. These divergent models reflect deeper ideological divides over innovation, ownership, and resilience. In the field of biopharmaceuticals, pedigree pogil has emerged as a critical defense against counterfeit biologics and biofake drugs. The WHO estimates that 10% of medicines in low- and middle-income countries are substandard or falsified, with biological products like insulin and monoclonal antibodies particularly vulnerable to contamination or mislabeling. Legal pluralism, recognizing customary rights alongside patent regimes, is essential to prevent biopiracy and uphold justice.
