However, implementation hurdles persist: teacher training deficits, rural-urban divides, and cultural resistance to student-centered pedagogy. In Sub-Saharan Africa, mobile technology has become a key enabler. Kenya’s “JAMII” platform uses SMS-based behavioral nudges to improve school attendance, sending personalized reminders and incentives tied to positive social norms. In Nigeria, AI-driven tutoring apps adapt content delivery based on real-time performance and attention patterns, attempting to simulate one-on-one mentorship at scale.
