The role of financial institutions and trade agreements further entrenches this power. Banana producers, especially smallholders, rely on credit from banks and export credit agencies, often tied to corporate contracts that lock them into unfavorable terms. International financial bodies such as the World Bank and Inter-American Development Bank have historically supported infrastructure projects—roads, ports, cold storage—designed to enhance export capacity, frequently benefiting corporate interests over local needs. Executive compensation, tied to stock performance, incentivizes cost-cutting measures that often fall hardest on labor and environment. Internal audits and compliance reports, while increasingly common, frequently serve reputational management rather than genuine reform. This structural misalignment—between corporate incentives and societal well-being—perpetuates cycles of exploitation and ecological degradation. The rise of “ethical sourcing” certifications—Fair Trade, Rainforest Alliance, UTZ—represents a partial response to these imbalances, yet their impact remains contested. While these programs offer higher prices and improved labor standards for participating farms, they cover only a fraction of global production. Certification costs, bureaucratic hurdles, and market access limitations exclude many smallholders. Moreover, audits are often conducted by third parties with conflicts of interest, and enforcement varies widely across regions. Critics argue that such schemes risk greenwashing—presenting superficial reform while preserving underlying extractive logic. TR4 spreads through contaminated soil, water, and equipment, with no known cure. The response—eradication through burning entire plantations—destroys not only crops but also surrounding habitats, accelerating ecosystem collapse. Soil health deteriorates under continuous cultivation, as synthetic fertilizers replace natural nutrient cycles. Overuse of pesticides and herbicides contaminates groundwater, affecting both human health and aquatic life.
