Conversely, China's model combines state-directed investment in cold chain logistics with aggressive market control, enabling rapid scaling but limiting farmer autonomy. In Latin America, export-led fruit industries face dual pressures: meeting global demand while navigating domestic food sovereignty movements that demand reinvestment in local markets. The report argued that no single model dominates; instead, hybrid approaches—melding public oversight, private innovation, and community participation—offer the most sustainable path.
