Meanwhile, China's zero-COVID policy disrupted global manufacturing, while U.S. tech export controls—targeting Huawei and advanced chipmakers—accelerated Beijing's push for self-reliance. This technological bifurcation deepened as the U.S. imposed sweeping restrictions on semiconductor exports to China, citing national security. The resulting decoupling fractured global supply chains, forcing firms to “friend-shore” or “near-shore” production—a costly, inefficient realignment. Amid this, geopolitical tensions simmered. U.S.-China relations deteriorated to Cold War levels, with Washington restricting investments in Chinese tech and Beijing retaliating with export controls on rare earths. The Middle East, long a flashpoint, saw renewed instability: the Abraham Accords offered fragile hope, but the Gaza war in 2021 and subsequent regional flare-ups underscored enduring volatility. Economically, the foundation for crisis was laid in inflation. Post-lockdown demand surged, but supply chains remained constrained. The Federal Reserve, initially slow to react, began raising rates in March 2022. But by then, inflation had already peaked—CPI in the U.S. hit 9.1% in June, driven by energy, housing, and food costs. The Fed's aggressive tightening, while necessary, deepened recession fears. Emerging markets, reliant on dollar financing, faced debt crises. Sri Lanka defaulted in 2022; Ghana and Pakistan teetered. The IMF warned that 60% of low-income countries were in debt distress. In this environment, the seeds of systemic fragility were sown:

State-sponsored actors, from Russian troll farms to Chinese influence networks, exploited social media algorithms to amplify division. Fact-checking organizations were overwhelmed—only 30% of viral content was debunked in real time. The geopolitical dimension intensified. Ukraine's counteroffensive, stalled by Western aid delays and Russian counterattacks, drained European morale. NATO's unity frayed as some members questioned U.S. commitment. In the South China Sea, Chinese naval

patrols increased, while ASEAN nations struggled to coordinate a unified response. The G20 summit in November 2023, once a forum for consensus, devolved into a theater of competing blocs—democracies vs. authoritarian coalitions, Global North vs. Global South—each advancing divergent visions of order. The economic toll was staggering. The IMF revised global growth forecasts downward to 3.1% for 2024, the lowest since 2009. Inflation persisted in many regions, defying central bank resolve. Emerging markets, already burdened, faced currency collapses—Turkey’s lira lost 40% of its value; Argentina’s debt crisis deepened. The World Bank warned that climate-related disasters had increased by 50% since 2010, with low-income nations bearing the brunt. Yet amid the chaos, a quiet transformation unfolded. Governments accelerated strategic autonomy initiatives. The EU launched the Chips Act, pledging €43 billion to domestic semiconductor production. India expanded its production-linked incentive (PLI) scheme, aiming to reduce import dependence. The U.S. CHIPS and Science Act allocated \$52 billion, while the Inflation Reduction Act tied climate investments to domestic manufacturing. These moves signaled a shift from globalization to
