This selective storytelling was not passive. It was institutionalized. School boards, often dominated by white landowners and business elites, dictated content. Teachers, many with limited training, replicated these

narratives without critical engagement. The result was a curriculum that naturalized inequality, teaching students that the American project in California was inevitable and benevolent. As historian Nancy Shoemaker observes, “Early textbooks constructed a civic myth that equated territory with destiny, obscuring the violence required to achieve it.” By the early 20th century, as California industrialized and urbanized, the curriculum adapted—but retained its foundational bias. Civics education emphasized patriotism, military service, and economic growth. Textbooks celebrated industrialists and political leaders, framing progress as a linear ascent. Yet the same era saw the rise of reform movements—labor unions, settlement houses, and nascent civil rights organizations—that challenged these narratives. African American newspapers, such as the **Oakland Tribune**, and Mexican American groups like the League of United Latin American Citizens (LULAC) began publishing counter-materials, demanding recognition of marginalized contributions. These counter-narratives, however, remained outside the formal curriculum. State education authorities resisted incorporating ethnic perspectives, fearing fragmentation.
