In Bangladesh, epigenetic risk profiling now guides maternal health programs, identifying women at high risk for preeclampsia years before symptoms appear. These applications reflect a deeper philosophy: molecular biology must serve equity, not just innovation. Expert perspectives underscore this shift.
