Myanmar's military junta, facing international isolation and economic collapse, has weaponized displacement as a tool of control, restricting humanitarian access and manipulating refugee flows. Simultaneously, Bangladesh's hosting government balances pressure from global donors with domestic security concerns, creating a liminal space where millions live in perpetual uncertainty. In this environment, individuals like Maimuna—uncounted, unregistered, unrecognized—become testaments to systemic failure.

Industry Impact: The Algorithmic Marginalization of Statelessness

Maimuna Begum's story intersects with the rise of algorithmic governance in humanitarian aid. In recent years, agencies such as UNHCR and the World Food Programme have increasingly relied on biometric databases, machine learning, and digital identity frameworks to manage refugee populations.
