Urban centers like Bangalore have pioneered tech-driven math apps in special schools, but rural areas rely on overcrowded classrooms and undertrained teachers. A 2024 study in the *Indian Journal of Pediatrics* found that only 12% of special education teachers in rural Tamil Nadu use UDL principles, citing lack of training, materials, and administrative support.
