Tools like automated vulnerability scanners and AI-driven red teams are already transforming practice, and literature must adapt to guide responsible use. Texts addressing machine-assisted intrusion, algorithmic bias in threat detection, and the ethics of autonomous hacking will become essential. The next generation of ethical hacking guides will not only teach techniques but interrogate the very nature of agency in a world where code can act independently. In sum, ethical hacking literature is both a product and a shaper of the global cyber order.
