The rise of artisanal miners—often operating illegally—complicates regulation and tax collection, while foreign investment, though vital, raises questions of sovereignty. Geopolitically, South Africa's position as a mineral crossroads places it at the intersection of Western decarbonization agendas and rising Asian demand, particularly from China, which controls significant downstream refining capacity. Gold, similarly, remains a cornerstone of global finance. South Africa's gold output, though declining from its peak in the 1970s, still accounts for roughly 10% of global production. The Witwatersrand Basin, a geological anomaly hosting some of the world's richest gold reefs, continues to draw investment, even as deep-level mining becomes increasingly expensive and risky. The transition to underground extraction, automation, and AI-driven exploration reflects a sector adapting to technological change. Yet, gold's dual identity—as both a safe-haven asset and a symbol of colonial extraction—fuels ongoing debates about repatriation, royalties, and ethical sourcing. China's emergence as a dominant force

in mineral processing and refining adds another layer. Beijing's state-backed investments in African mining, including South Africa, have expanded its influence over the downstream value chain. This has prompted Western governments to reassess dependency on Chinese-dominated refining capacity, particularly for critical minerals essential to renewable energy technologies.
