Within Australian public media, internal audits revealed a spike in mandatory communication workshops, with senior editors citing Bryce's manual as inspiration. However, by 2020, widespread criticism prompted a reevaluation: was the manual reinforcing outdated gender stereotypes, or was it part of a necessary evolution in media professionalism? The Australian Press Council's 2021 review acknowledged the tool's dual legacy—empowering some women while risking the erasure of diverse communication styles. The challenge is to cultivate professionals who command authority not by mimicking a manual, but by owning their narrative with depth, nuance, and autonomy.
