Second, quantum computing may soon enhance ZR13's modeling capacity, enabling near-instantaneous analysis of complex financial networks at unprecedented scale. Third, the integration of decentralized identity (DID) protocols could allow ZR13 to verify client credentials across borders without centralized data repositories—addressing longstanding privacy concerns. Yet, these advancements demand parallel progress in governance. As ZR13's influence grows, so too must multilateral cooperation.
