sugar accumulation and phenolic imbalance, requiring advanced clonal selection and precision harvest scheduling. In contrast, Chile's Colchagua Valley, benefiting from state-backed irrigation modernization, demonstrates how infrastructure investment can buffer climate volatility. The atlas underscores that wine's future is not just about survival, but transformation—where geography, technology, and policy converge to redefine excellence.

Geopolitical Currents and Wine's Role in Soft Power

Russia’s historical affinity for French Bordeaux has eroded amid sanctions, redirecting €1.2 billion in annual wine trade to Turkey, the Caucasus, and Central Asia.
