These crops, once limited to short seasonal windows, now flow into European and North American markets with consistent supply, boosting foreign exchange earnings and rural incomes. However, this growth was facilitated by complex geopolitical dynamics: U.S.-Vietnam trade normalization in the 2000s, followed by ASEAN-China economic integration, created favorable conditions for agricultural exports. Environmental economists like Dr. Amara Nkosi warn of a "greenwashing" risk: the allure of Zone 10b as a solution may distract from deeper systemic issues. 'We must not mistake technological adaptation for resilience,' she cautions. 'If we expand agriculture into marginal zones without addressing water scarcity, soil degradation, and carbon emissions, we may simply accelerate the very crises we seek to mitigate.' In academic circles, the debate has sharpened around data accuracy and predictive modeling. While projects like USDA's Prism and Europe's Copernicus Climate Change Service have refined microclimate mapping, uncertainties

remain—especially under high-emission scenarios. A 2024 study in *Nature Sustainability* found that current models underestimate the frequency of extreme heat events in Zone 10b regions, raising concerns about crop failure risks. ‘Climate models are improving,’ acknowledges Dr. Raj Patel, a climate risk analyst at the International Institute for Environment and Development, ‘but they still struggle with hyperlocal variability.
