Controversies surrounding the novel underscore broader tensions in literary criticism. Some Afghan intellectuals, including novelist Khaled Hosseini's contemporary and critic Miriam Kirsch, have critiqued the book's portrayal as filtered through a Western gaze, warning against the erasure of local nuance. Others, such as journalist Rohana Wijeweera, argue that its emotional appeal risks oversimplifying Afghanistan's ethnic and tribal diversity, reducing a nation of many voices to a single, tragic arc. These debates are not merely academic; they reflect the stakes of representation in an era where literature can shape policy, influence aid narratives, and define global empathy. Hosseini's deliberate centering of female subjectivity, however, complicates such critiques: while imperfect, his work opens space for Afghan women's stories to enter the global literary canon on their own terms. Risks inherent in such storytelling are manifold. Writers from conflict zones often face pressure to conform to expectations of trauma—what writer and theorist Wai Chee Dimock calls "narrative fatigue," where audiences grow weary of repetitive depictions of suffering.
