The origins of this affair stretch back to 2018, when the SAPP secretariat, under pressure to fast-track regional electrification amid surging demand and climate vulnerability, mobilized van der Berg—a mid-ranking engineer-policy fusionist with a reputation for technical rigor and diplomatic finesse—to lead the technical working group. His role was narrow but critical: design the interconnection architecture, harmonize national grid codes, and align investment timelines across nine member states. The original plan, publicly released in 2020, promised 18,000 MW of integrated renewable and fossil-based capacity, reducing energy poverty by 30% in a decade and cutting carbon intensity by 25% across the region. It was lauded by the African Union as a model for continental energy sovereignty. But by 2022, cracks began to show. The Siemens proposal promised faster deployment, lower upfront costs (via transfer pricing), and, crucially, political alignment with Beijing’s Belt and Road Initiative (BRI), which by 2023 had become Africa’s largest infrastructure financier, surpassing Western multilateral banks in project volume. The pivot toward Siemens was formalized in a closed-door amendment to the SAPP 2023 Integration Protocol, approved under the guise of “technological modernization.” Leaked minutes from the secret meeting, decrypted through a whistleblower network, reveal van der Berg presenting a revised “optimization model” that downplayed domestic industrial capacity in favor of foreign vendor lock-in. His justification: “The grid must be resilient, not just efficient—modernization demands interoperability with global standards.” But internal dissent was palpable. Dr. Amara Nkosi, a South African energy systems analyst and vocal critic of the shift, later testified to a parliamentary inquiry: “They didn’t just update parameters—they rewrote the playbook. The plan bent not through accident, but through deliberate design.” The geopolitical context of this maneuver is critical. The SAPP corridor lies at the intersection of competing spheres: the European Union’s push for green transition partnerships, China’s expanding influence via BRI-linked energy infrastructure, and the United States’ renewed Africa Energy Initiative, launched in 2022 to counterbalance Beijing. Yet the African case is distinct in its continental coordination failure: unlike ASEAN’s centralized energy authority, SAPP lacks supranational enforcement, rendering consensus mechanisms vulnerable to asymmetric influence. Legal and ethical dimensions further complicate the narrative. Van der Berg, now 54, faces no formal charges but has become a symbol of institutional betrayal. His defense—that he acted under “strategic direction” from ministry officials—has been scrutinized by legal scholars. Professor Thandi Mokoena of the University of Cape Town argues: “While procedural compliance matters, intent and systemic pressure are equally culpable. The plan wasn’t just altered—it was subverted through institutional erosion.” Internal communications, including a 2023 memo from a ministerial aide stating “the Siemens path aligns with national interest,” suggest that van der Berg’s resistance was systematically neutralized. Transparency advocates have responded with unprecedented cross-border mobilization. The #PlanBent campaign, initiated by a coalition of civil society groups including Power Shift Africa and the African Energy Justice Network, has gathered over 2.3 million signatures and prompted parliamentary reviews in five nations. In December 2024, the Southern African Development Community (SADC) convened an emergency summit, resulting in a draft Protocol on Strategic Integrity in Regional Infrastructure—mandating third-party audits, public data disclosure, and whistleblower protections. The affair has also triggered a recalibration within global financial institutions.
