However, these institutions embedded Western dominance, privileging dollar-based systems and marginalizing postcolonial voices. As economist Ha-Joon Chang observes, the postwar order was a “managed peace,” balancing power among victors while constraining the agency of the Global South.

The Cold War (1947–1991) redefined global politics as a standoff between U.S.-led liberal democracy and Soviet-led communism. This ideological contest played out not only in proxy wars—Korea, Vietnam, Afghanistan—but in space races, nuclear deterrence, and propaganda.
