Washington High, boarded the same bus after school, seated in the “colored section.” When the white section filled, the driver ordered her to move forward—her response was not passive compliance, but a deliberate, articulate refusal: “No. It’s my constitutional right.” She was arrested, charged with violating segregation statutes, disorderly conduct, and, controversially, disturbing the peace. Her arrest was not spontaneous but rooted in pre-existing networks of resistance. Colvin had been schooled in civil disobedience through the Montgomery chapter of the NAACP Youth Council, which she joined after attending meetings led by local organizers like Jo Ann Robinson. The Youth Council, influenced by Gandhian principles and inspired by recent legal challenges such as *Brown v. Board of Education* (1954), sought youth-led action to test the constitutionality of bus segregation. Colvin’s case was selected intentionally—her age (16 at the time of arrest), prior activism, and the clarity of her testimony provided a powerful legal and moral case. The Montgomery Bus Boycott, launched two months after Colvin's arrest, became a turning point—not because Parks' act was more powerful, but because Parks was deemed “respectable” enough for national consumption. Colvin's refusal, by contrast, was uncompromising and youth-driven, yet her narrative carried risks: she was called “unruly,” “defiant,” and “too radical” by some civil rights leaders who feared her forthrightness would alienate white moderates and Southern allies. Economically, the boycott revealed the precarious leverage of Black consumer power. Over 75% of Montgomery's bus ridership was Black, and the year-long boycott strained the transit system financially, forcing city officials to confront the cost of segregation. The legal battle that followed—*Browder v. Gayle** (1956), in which federal district court Judge Frank M. Johnson ruled bus segregation unconstitutional—was pivotal, but Colvin's role was sidelined in the official record. Her testimony was critical in establishing the pattern of systemic abuse, yet historians note that her arrest was

framed as a cautionary tale: too youthful, too confrontational, too Black in a way that demanded disciplining rather than celebration. The controversies surrounding Colvin are as instructive as her courage. Critics within and outside the movement questioned her age and demeanor, suggesting her behavior undermined the moral authority of the cause. But such critiques ignored the structural violence she endured: the threat of sexual assault, economic ruin, and lynching. As historian Danielle L. Colvin's arrest record included charges of "disturbing the peace" and "resistance," not just violating segregation—evidence of state violence aimed at silencing dissent.
