For example, a fund could borrow U.S. Treasury bonds in a tax-efficient offshore brokerage, short them, and sell them in New York, locking in a spread while relying on collateral to cover margin calls. This cross-border arbitrage became a blueprint for global borrow trading, leveraging regulatory differences in tax, capital requirements, and disclosure. The 2000s deepened this complexity. The proliferation of prime brokerage services—intermediaries that manage clearing, financing, and collateral for hedge funds—integrated borrow trading into broader capital deployment strategies.
