defended this approach as necessary in a competitive market where “disruption rewards audacity.” Yet critics argue it normalized a culture where short-term gains overshadowed long-term trust—a dynamic that would later fuel public backlash. The turning point came in 2018, amid a global reckoning with corporate misconduct. A whistleblower within her network leaked documents exposing a coordinated campaign to amplify divisive content through algorithmic manipulation, targeting vulnerable demographics to boost ad revenue. Though Kearns publicly condemned the practice, internal investigations uncovered a deliberate strategy to downplay internal dissent and deflect scrutiny through legal posturing.
