Federal agencies such as Customs and Border Protection (CBP) and Immigration and Customs Enforcement (ICE) operate with overlapping jurisdictions and minimal oversight. Local sheriffs, often underfunded and politically pressured, avoid jurisdictional entanglement, refusing to investigate when federal actors are involved. Meanwhile, private security contractors—employed by ranches, mines, and border logistics firms—function as de facto enforcers, their actions shielded by non-disclosure agreements and layers of corporate insulation. The economic architecture underpinning this violence is deeply entrenched. Large agribusinesses like Tyson Foods subsidiaries and cattle empires rely on low-cost, often undocumented labor, creating a dependency that disincentivizes protection. Mining corporations, including Freeport-McMoRan and smaller extraction firms, leverage state contracts to secure land rights, frequently displacing communities under the banner of “economic progress.” The border infrastructure boom—\$25 billion in federal spending since 2015 on walls, sensors, and detention centers—has paradoxically increased risk: by channeling migration into narrower, more treacherous corridors, it amplifies exposure to extreme weather and predatory violence. Expert analysis reveals a disturbing pattern: violence has become structurally embedded. Families are torn apart without closure; survivors suffer from complex trauma without access to mental health services; communities erode under the weight of collective grief. Yet resistance persists. Grassroots organizations like the Border Justice Network and Colectiva de Mujeres del Desierto have established clandestine memorials, documented testimonies, and pressured international bodies—including the Inter-American Commission on Human Rights—to intervene. Large agribusinesses, supported by state tax abatements and federal subsidies, have consolidated control over water rights and farmland—displacing smallholder farmers and Indigenous communities. The Lipan Apache, whose ancestral territories span Presidio and Brewster counties, have seen sacred sites seized for cattle grazing and solar farm development, often without consultation. Their displacement is not incidental but systemic: land

use decisions prioritize extractive capitalism over cultural survival. Simultaneously, mining operations—particularly for copper and lithium—have expanded under relaxed environmental regulations, fragmenting ecosystems and contaminating water sources. These projects, often partnered with federal infrastructure grants, rely on a transient workforce, further destabilizing communities. Yet this militarization has not reduced violence; it has redirected it. By channeling migrants into narrower corridors, infrastructure increases exposure to extreme heat, dehydration, and ambush. Smugglers, adapting to technology, now use GPS jammers and drone diversions, escalating risk.
