Its architects drew on both indigenous philosophies—Confucian respect, Buddhist interdependence—and Western ethical frameworks, synthesizing a hybrid model suited to multinational enterprise. The 2002 revision, prompted by the Enron collapse and rising global scrutiny of corporate

governance, infused stronger legal and compliance elements, aligning Kyoshin with OECD Guidelines and emerging UN principles on business and human rights. The resulting draft—later formalized as the Kyoshin Guide for Honor—was not a reactive measure but a strategic reorientation.
