In a world where engagement is monetized, Kh Re's model prioritizes authenticity over virality, offering a counter-narrative to the attention economy's erosion of depth. Financially sustainable yet anti-surveillance, it represents a blueprint for ethical data stewardship—one where users are not products but custodians.

Expert Perspectives: The Tension Between Memory and Technology
