Its rigor reflects a state-driven meritocracy but also pressures a population of over 250 million students, raising concerns about mental health and educational sustainability. These systems emphasize high-stakes rigor, with national exams often determining access to top universities and, by extension, national innovation pipelines. China's Gaokao, perhaps the most consequential, combines regional and national layers into a single, life-altering event, reinforcing a societal investment in mathematical precision**

**as a pathway to upward mobility. The result is a population deeply trained in algorithmic thinking, procedural fluency, and disciplined problem-solving—attributes prized in global tech and manufacturing sectors. In contrast, the United States maintains a decentralized, fragmented approach, with no federal summative math mandate. Yet, state-level testing consortia—such as PARCC and SBAC—have adopted Common Core-aligned assessments that emphasize conceptual understanding and application, reflecting both domestic reform goals and global competitiveness pressures. The U.S.**

**Department of Education's push for "college and career readiness" metrics further embeds math summative evaluation within broader economic narratives, pressuring schools to align curricula with standardized benchmarks. However, this model faces challenges in equity and coherence, with performance gaps persisting across socioeconomic lines. The European Union presents a hybrid paradigm. While member states retain autonomy, PISA rankings influence national policy, prompting reforms in countries like Germany and Finland. Finland's cautious integration of summative**

**testing—retaining its focus on formative feedback—demonstrates an alternative vision: balancing accountability with pedagogical integrity. Yet, even here, rising pressure from international assessments has spurred incremental shifts toward performance-based elements.
