Yet Piaget's model faced critique for underestimating cultural variation in abstract reasoning. Indigenous epistemologies, for example, often prioritize relational, contextual knowledge over abstract formal logic. In such contexts, “formal operational” language may manifest differently—through storytelling, communal deliberation, or embodied practice—challenging Western-centric benchmarks.
