In Colombia, post-conflict case documentation centers on truth-telling, with victims’ stories forming part of transitional justice processes. Africa reveals further complexity. In Kenya, participatory case studies empower youth in slum communities to document their realities, challenging top-down development narratives. Yet in contexts of political repression—such as Ethiopia or Zimbabwe—case documentation risks state surveillance, forcing practitioners to navigate secrecy and danger. These global variations underscore a central insight: the case study’s efficacy depends not on the method itself, but on how it is adapted to local power structures, cultural epistemologies, and institutional capacities. Its universality lies not in form, but in its capacity to honor context.

Long-Term Implications and Strategic Futures

Looking ahead, the case study social work faces both transformative opportunities and existential challenges. Technological integration—AI-driven pattern recognition, blockchain-secured case records, virtual reality storytelling—promises deeper analytical depth and enhanced client agency. Yet these tools demand critical oversight: AI may amplify biases if trained on flawed data; digital permanence risks violating evolving consent norms. The profession must advance toward more participatory, decolonized forms of case work. This means centering client authorship, supporting community-led documentation initiatives, and integrating indigenous knowledge systems. The rise of “narrative justice” frameworks—where stories inform legal and policy change—suggests a future where case studies are not merely assessment tools but instruments of systemic transformation. Globalization also pressures standardization versus localization. As transnational social challenges—climate migration, digital exploitation, global health inequity—escalate, case studies must evolve into cross-border, networked practices. International coalitions, such as the Global Network for Social Work Narratives, are already fostering shared standards while respecting cultural specificity. Crucially, the case study’s future hinges on institutional support. Without sustained investment in training, supervision, and ethical infrastructure, the method risks marginalization in favor of faster, less reflective practices.
