This raises concerns about surveillance and control, highlighting how clean PDFs can serve both transparency and authoritarian ends.

Industry Disruption and the Financialization of Trust

The financial sector has become a key driver of clean PDF adoption. Green bonds, sustainability-linked loans, and ESG disclosures now depend on verifiable PDF records.
