Unlike traditional espionage, today’s threats combine hacking, social engineering, and psychological manipulation—tools calibrated to discredit, isolate, and deter. Moritz’s network, though decentralized, had become a high-

value target precisely because it exposed the “dark layer” of digital governance—systems designed to obscure power behind code and contract. The geopolitical context amplifies this narrative.
