In Japan, seismic resilience has driven innovation in hybrid timber-concrete systems, blending traditional craftsmanship with modern engineering. Yet it was the 21st century that transformed wood from a regional specialty into a continental standard. Sweden’s approach, shaped by dense forests and a culture of innovation, evolved through the Swedish Wood Construction Standard (SWS), first published in 2004. Unlike purely prescriptive codes, SWS integrated performance-based criteria, allowing engineers to demonstrate compliance through testing rather than rigid formulas. This flexibility enabled early adoption of large-scale projects, such as the 2009 10-story wooden apartment block in Malmö, which showcased timber’s viability in high-density urban settings. Sweden’s success catalyzed broader Nordic collaboration under the Nordic Standards (Nordstandard) framework, harmonizing technical language while preserving national adaptations. In North America, the breakthrough came not from regulation alone, but from cross-sector innovation. The U.S. Forest Products Association, alongside architectural firms like Katererra and timber manufacturers such as Adama, lobbied aggressively for code recognition. The pivotal moment arrived in 2018 with Section 2305 of the International Building Code, which formally permitted Type IV construction—mass timber—up to 18 stories in non-combustible zones. This was not a passive acceptance but a negotiated compromise, requiring extensive fire-testing data and risk modeling. Canada followed suit with its National Building Code revisions, introducing the 2020 Wood Design Code (WDC), which incorporated performance-based fire resistance and moisture management protocols tailored to its cold, variable climate. China’s trajectory diverges sharply. With timber resources limited and urbanization pressures acute, the Ministry of Housing and Urban-Rural Development launched the Mass Timber Construction Technical Standards in 2021, aligning with the country’s “dual carbon” goals. State-backed initiatives like the China National Wood Industry Development Plan promoted CLT production and prefab construction, positioning wood as a strategic material for sustainable urban expansion. Unlike Western models focused

on regulatory integration, China's approach reflects a top-down industrial policy, leveraging timber as both ecological and economic infrastructure. These national frameworks reveal deeper geopolitical currents. In the European Union, harmonization efforts under Eurocode 5 sought to unify technical language across member states, yet national interpretations persist—Germany's stringent fire safety protocols contrast with Finland's emphasis on lifecycle carbon accounting. The EU's Green Deal and Circular Economy Action Plan further incentivize wood's role, but tensions remain between centralized standardization and national sovereignty, especially in countries with strong regional construction traditions. In Asia, Japan's Wood Construction Standards evolved in response to both seismic vulnerability and cultural aesthetics. The 2002 revision introduced advanced lateral-force resistance systems for timber frames, enabling mid-rise wooden housing in earthquake-prone zones. Unlike Western codes, Japanese specs prioritize detailed moisture control and joint detailing, reflecting a craftsmanship ethos fused with modern engineering. Meanwhile, South Korea's 2022 update incorporated passive design principles, mandating high thermal performance and natural ventilation in timber buildings—aligning wood construction with broader climate resilience goals. The United Kingdom's journey illustrates how policy can pivot on crisis. Following the 2017 Grenfell Tower tragedy, which exposed systemic failures in combustible cladding, the UK Construction Design Manual (CDM) was revised to include mandatory fire performance for all timber assemblies, even in high-rise buildings. The 2023 revision of the Britain's Standard BS 8414 further required fire-structural testing for CLT, reinforcing a culture of evidence-based regulation. This shift underscores a broader trend: wood's acceptance is not automatic but earned through demonstrable safety and performance. Economically, national specifications reflect strategic industrial positioning. In the U.S., states like Oregon and Washington led early adoption, supported by state forestry departments and universities investing in mass timber R&D. Oregon's 2020 Wood Construction Code amendment permitted 12-story timber buildings, catalyzing a wave of projects including the 2022 18-story Framework Tower

in Portland—America’s tallest mass timber structure at the time. These regional leaders leveraged local timber supply chains, creating jobs and reducing import dependency, but faced pushback from steel and concrete lobbies wary of market disruption. China’s national specs, by contrast, reflect centralized ambition. The 2021 revision mandated that 30% of new urban housing use engineered wood by 2030, backed by state financing and industrial subsidies. This top-down push has accelerated CLT adoption in cities like Shenzhen, where timber high-rises now symbolize China’s technological ascent. Yet challenges persist: supply chain bottlenecks, limited skilled labor, and inconsistent enforcement in smaller municipalities hinder uniform implementation.
