Its core concepts—*dharma* (duty), *karma* (action and consequence), and *moksha* (liberation)—define a cyclical, pluralistic worldview centered on cosmic order rather than linear revelation. Hinduism's institutional diversity—countless sects, rituals, and regional traditions—reflects India's cultural stratification and philosophical depth. The caste system, though historically rigid, evolved into a complex social hierarchy intertwined with religious identity, often criticized yet persisting in forms both overt and subtle. Colonialism

disrupted traditional structures, but post-independence India enshrined secularism in its constitution, allowing religious pluralism to flourish despite periodic tensions. Economically, Hindu-majority India is a rising global power, with a youthful population driving technology, services, and cultural industries. Hindu temples function not only as spiritual centers but also as economic hubs, managing vast assets, landholdings, and charitable networks. The global Hindu diaspora—over 30 million—spreads influence across the UK, US, Canada, and the Caribbean, sustaining transnational connections and soft power. The interface between Judaism, Islam, and Hinduism reveals layered patterns of coexistence, friction, and mutual adaptation shaped by history, politics, and economics. In India, centuries of religious overlap—especially in regions like Gujarat, Kerala, and Kashmir—have produced syncretic traditions: Sufi and Bhakti saints venerated across faiths, shared festivals, and intermarriage in localized communities. While medieval periods saw periods of syncretism—such as Mughal-era architecture and poetry—the colonial era institutionalized religious divisions through census categorizations and political mobilization. Post-independence, India’s secular experiment faces strain from Hindu nationalist movements, influencing policy, education, and social cohesion, while Muslim communities assert identity amid discrimination and surveillance. Economically, religious affiliation influences labor markets,

entrepreneurship, and investment patterns. In Indonesia, Islamic finance integrates with national development goals; in India, Hindu nationalist economic policies favor particular communities, affecting market access. Initiatives like the Common Word movement and the Parliament of the World's Religions foster sustained conversations, though institutional inertia and political polarization remain significant barriers. This contrasts with Abrahamic exclusivity claims but invites reflection on how religious frameworks enable or constrain interfaith relations. Globally, the rise of “spiritual but not religious” identities complicates traditional models, yet sacred traditions remain vital

anchors. In East Asia, Confucian ethics subtly shape interreligious attitudes; in Africa, syncretic Christian-Muslim communities blend ancestral traditions with imported faiths; in Latin America, Catholicism intertwines with indigenous cosmologies.
