Wealthy nations monopolized advanced scanners and AI-driven analytics, while low- and middle-income countries (LMICs) struggled with basic access to even basic neurological care. The global burden of brain disease, already staggering, became a stark inequality: over 75% of people with neurological disorders live in LMICs, where one in three cannot access diagnosis or treatment. Clinical cases from Lagos, Mumbai, and Managua reveal not just disease, but systemic failure—where neuroanatomy is understood in theory, but ignored in practice. The case of ketamine’s rapid antidepressant effects, tied to NMDA receptor modulation in the prefrontal cortex, exemplifies both promise and peril: while transformative for some, its neuroanatomical mechanisms remain incompletely understood, and long-term safety in varied genetic and environmental contexts is unclear. Economically, the global neurotechnology market is projected to exceed \$100 billion by 2030, driven by wearables, AI diagnostics, and neuromodulation devices. Yet access remains skewed: Silicon Valley startups pioneer brain-computer interfaces for paralysis, while rural clinics in Sub-Saharan Africa lack basic neurologists. This digital neurodivide mirrors broader inequities—where neuroanatomy becomes a commodity measured in patents and profit, rather than a universal human experience. Expert perspectives reveal a field in flux. Dr. Alvaro Pascual-Leone, neurologist and neuroplasticity researcher, argues that neuroanatomy must be reimaged as dynamic and participatory: the brain is not a machine to be fixed but an organ shaped by experience, learning, and culture. His work with transcranial magnetic stimulation (TMS) in stroke recovery demonstrates how stimulating specific cortical regions can rewire function—blurring the line between anatomy and plasticity. Yet, colleagues caution against overpromising: neuroanatomy reveals patterns, not certainties. As Dr. Lisa Feldman Barrett, founder of constructed emotion theory, notes, “The brain interprets, it does not merely compute.” Understanding circuits without context risks hubris. Controversies persist, particularly around neuroimaging’s role in justice and identity. Cases involving “brain scans” in legal defenses—claiming diminished responsibility due to frontal lobe injury—raise profound ethical questions. Can a scan prove free will? In the 2013 Italian trial of a man charged for arson, a PET scan showing reduced prefrontal activity was cited, sparking global debate. While neuroscience offers new insights, it cannot resolve moral responsibility—only illuminates biological context. The danger lies in conflating correlation with causation, reducing complex human behavior to neuroanatomical snapshots. Global comparisons further expose structural inequities. In Sweden, universal healthcare ensures rapid MRI access and multidisciplinary neuropsychological care for traumatic brain injury (TBI) survivors. In contrast, in Brazil, despite advances in neuroimaging, underfunded public hospitals face shortages of radiologists and neurologists—especially in the Amazon region, where TBI from deforestation accidents often goes undiagnosed. These disparities are not technical but political: neuroanatomy’s benefits are distributed according to power, wealth, and governance. The long-term implications of this clinical and neuroanatomical trajectory are staggering. As wearable EEGs and implantable neural monitors become routine, real-time tracking of brain activity will redefine disease monitoring and intervention. Imagine a future where Alzheimer’s pathology is detected years before symptoms—through subtle changes in hippocampal connectivity—allowing preemptive modulation of circuits via targeted stimulation. But this

future demands ethical guardrails: privacy, consent, and equitable access must precede technological rollout. Neuroanatomy, once the domain of specialty clinics, is becoming central to public health policy. The WHO's "Mental Health Action Plan" now emphasizes neurobiological literacy, urging governments to integrate brain health into primary care. In Rwanda, a pilot program trains community health workers to recognize early neuroanatomical signs of stroke and depression using mobile AI tools—bridging the gap between clinical science and grassroots practice. This represents a paradigm shift: neuroanatomy is no longer confined to academic journals but embedded in community resilience. Yet, the field faces existential risks. Overreliance on neuroimaging threatens to depersonalize care, reducing patients to data points. The "neuroreductionist" critique persists: can a 3D brain scan capture the grief of loss, the joy of birth, or the trauma of displacement? The answer lies in narrative—neuroanatomy must coexist with patient stories, cultural insight, and social analysis. As Dr. V.S. His symptoms emerged after a year of relentless work under South Korea's "hustle culture," defined by 80-hour weeks and zero work-life boundaries. Neuroimaging showed reduced gray matter volume and disrupted functional connectivity in the DLPFC, particularly with the anterior cingulate cortex—regions linked to decision-making and emotional regulation. Yet, the scan alone could not explain his collapse. Mental health history included childhood neglect, chronic sleep deprivation, and social isolation masked by digital interaction. The DLPFC lesion was real, but its manifestation was contextual—shaped by cultural expectations of overwork, economic pressure, and a society that equates productivity with self-worth. This case exemplifies a broader trend: neuroanatomical damage often unfolds in tandem with social and psychological stressors. The prefrontal cortex, evolutionarily the most recent addition to the human brain, governs higher cognition—yet it remains exquisitely sensitive to environmental inputs. Prolonged stress alters cortisol levels, impairing neurogenesis and synaptic pruning. In Seoul,



as in many East Asian megacities, the brain's executive circuits bear the cost of cultural productivity norms. The treatment plan integrated neurobiological and psychosocial interventions. Pharmacological agents targeting glutamate and dopamine pathways were introduced to enhance synaptic plasticity, while cognitive behavioral therapy (C
